PRIVATE/SEMI-PRIVATE SWIM LESSON POLICIES

- Private lessons must be completed within 2 months of 1st class. Any lessons not completed in that time will be lost.
- In case of thunder/lightning, the pool will be closed for 30 minutes after the last sound of thunder or sight of lightning. In this case, a make up lesson will be offered if less than 20 minutes of the class took place.
- Parents of children 12 and younger must remain on the pool deck during lessons. All other parents must remain in the YMCA building during the lesson.
- Unless participants/family are YMCA members or have purchased a day pool pass with proof of receipt, swimming before or after the lesson is not allowed.
- In the event the pool is contaminated, the Y pool will close until the water has been cleared and sanitized. This may result in the pool being closed for up to 24 hours.
- Semi-Private participants will be taught in the same 30-minute lesson. If one participant cannot make a lesson, they lose that lesson.
- Cancellations or rescheduling must be cleared by the instructor with a 24-hour notice.
- Any "no shows" will lose that scheduled lesson and will be unable to reschedule it.
- Payment is required at time of registration.
- COVID PROTOCOLS: 1) Only 1 guest allowed on the pool deck for participants. 2) Face masks are required when on the pool deck. 3) Once lesson is complete, participant and guest must immediately leave the pool deck.

Waiver, Release, Indemnification & Covenant Not to Sue
